



### ***Holt Hill Audio, LLC Three Year Transferable Warranty Information***

Holt Hill Audio, LLC, herein referred to as “HHA,” creates hand-crafted loudspeakers in small batches which may have slight variations from batch to batch. HHA reserves the right to make adjustments, modifications, or substitutions of products or components, in whole or in part, as HHA deems necessary.

HHA warrants its products to be free from functional defects in materials or workmanship (subject to the terms herein) for a period of not more than three (3) years from the original date of purchase (“Warranty Period”). During the Warranty Period, warranty coverage is extended to the final end-user of our products, original or secondary. Proof of Purchase will be required for both original and secondary users. Proof of Purchase shall be provided in the form of an original sales slip or product registration with HHA.

Original purchaser is required to fulfill a product registration card or online form within sixty (60) days of purchase. Transfer purchases must be recorded either via a product registration card or online form within thirty (30) days of said transfer.

HHA’s obligation under this warranty is limited to repairing and/or replacing any component which it finds defective in material or workmanship under normal, non-commercial operating conditions. Any replacement product will be warranted for the remainder of the original warranty period. All products requesting warranty service must have a valid and legible serial number matching that shown on the Proof of Purchase.

HHA will repair, replace or adjust defective parts for the original owner without charge for parts or labor under the following conditions: (1) All products must be packaged in original or equivalent packaging and accompanied by a Return Authorization (“RA”) document issued by HHA. (2) All transportation, packaging, and incidental charges associated with transporting the product from the purchaser to HHA will be borne by the purchaser. (3) Any damage to product incurred while in transit to HHA will be the sole responsibility of the purchaser. (4) All transportation, packaging, and incidental charges associated with transporting the product from HHA to the purchaser will be borne by HHA.

This warranty does not apply to damages resulting from abuse or misuse, accidental damage, faulty electronic equipment, or any post-purchase modifications or attempted repairs by anyone other than HHA, or an authorized agent working on behalf of HHA. HHA will not be responsible, nor liable, for any damages which may arise from the misuse of our products resulting from physical, incidental, consequential or indirect losses, including personal injury, both personal and business-related.

THIS LIMITED WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER EXPRESS WARRANTIES, IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED IN DURATION TO A PERIOD OF THREE YEARS FROM THE DATE OF PURCHASE.
